ORDER:

On 26.06.2009, Thiru. K. R. Anand, Ninth Ward Councillor and two councillors of Kottaiyur Town Panchayat, Sivagangai District presented a notice of 'No Confidence Motion' duly signed by twelve councilors, out of the 15 total councillors against Thiru. Suba. Vairavan, Chairman of Kottaiyur Town Panchayat Sivagangai District to the Assistant Director of Town Panchayat, Sivagangai Zone in person. The Assistant Director of Town Panchayat of Sivagangai by following the procedures laid down in section 40-A of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) served his letter dated 21.08.2009 to all the 15 councillors including the Chairman stating that the special meeting will be conducted on 08.09.2009 by 11.00 A.M.

2. As scheduled, a special meeting was conducted in the office of the Kottaiyur Town Panchayat by the Assistant Director of Town Panchayats, Sivagangai Zone on 8th September 2009 by 11.00 A.M. and all the 15 councillors attended the meeting. when the motion was put to vote 12 councillors have voted in support of the 'No Confidence Motion' against the Chairman of Kottaiyur Town Panchayat.

3. Therefore, the Assistant Director of Town Panchayats, has informed to the Director of Town Panchayat that 'No Confidence Motion' was declared passed since four-fifth of the sanctioned strength of the council have voted in favour of the motion with the reference to section 40-A (12) of Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920). In the circumstances, the Director of Town Panchayats has sent relevant documents regarding the removal of Thiru. Suba. Vairavan, Chairman, Kottaiyur Town Panchayat, Sivagangai District to the Government for suitable further action.

4. The Government have examined the report of the Assistant Director of Town Panchayats, Sivagangai Zone, with reference to the provisions of sub.sec(12) of section 40-A of the said Act, and decided to remove Thiru. Suba. Vairavan, Chairman, Kottaiyur Town Panchayat, Sivagangai District from the office of the Chairman of the said Town Panchayat. Accordingly, the following Notification shall be published in the Tamil Nadu Government Gazette, Extra-ordinary dated the 29th January 2010.

NOTIFICATION

Whereas a written notice of intention to make a motion expressing want of confidence in Thiru. Suba. Vairavan, Chairman, Kottaiyur Town Panchayat, Sivagangai District signed by twelve councillors out of the sanctioned strength of the fifteen councillors of the said council together with a copy of the motion proposed to be made have been delivered to the Assistant Director of Town Panchayats, Sivagangai Zone in person by three councillors under the provisions of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920);

And, Whereas the said motion expressing want of confidence in Thiru. Suba. Vairavan, Chairman, of the said Town Panchayat has been carried out with the support of twelve councillors out of the sanctioned strength of the fifteen councillors in the meeting convened by the Assistant Director of Town Panchayats, Sivagangai Zone, on the 8th September 2009, after following the procedures specified in section 40-A of the said Act;

Now, therefore in exercise of the powers conferred by sub-section (12) of section 40-A of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby removes Thiru. Suba. Vairavan, Chairman, Kottaiyur Town Panchayat, Sivagangai District from the office of Chairman of the said Town Panchayat.
