ORDER:

In the letter first read above, the Director of Municipal Administration has stated that the Government of India, Ministry of Housing and Urban Poverty Alleviation Lr. No. 24011/1/2009/UPA, dated 17.6.2009 have allocated a sum of Rs. 3817.38 lakhs for the year 2009 – 2010 for implementation of Swarna Jayanthi Shahari Rozgar Yojana Scheme in the State and the Government of India, Ministry of Housing and Urban Poverty Alleviation letter No. 24011/1/2009/UPA, dated 5.11.2009 have released a sum of Rs.19,08,69,000/- 50% of Central Share being the 1st installment.

2. Accordingly, in the G.O. second read above, a sum of Rs. 636.23 lakhs has been released as first Installment towards the proportionate State Share under Swarna Jayanthi Shahari Rozgar Yojana Scheme for implementation during 2009-2010.

3. The Director of Municipal Administration has further stated that in the letter third read above the Government of India, Ministry of Housing and Urban Poverty Alleviation have released the IInd Instalment of Rs.19,08,69,000/- and hence he has requested the Government to sanction and release the proportionate State share of Rs. 636.23 lakhs for the implementation of Swarna Jayanthi Shahari Rozgar Yojana scheme for the year 2009 – 2010.

4. The Government after careful examination accord sanction and release a sum of Rs. 636.23 lakhs (Rupees six hundred and thirty six lakhs and twenty three thousand only) towards the second installment of matching share of State Government under Swarna Jayanthi Shahari Rozgar Yojana for the year 2009 – 2010.

5. The expenditure sanctioned in para 4 above shall be debited to the following heads of account respectively as follows:-
