For the project of Water Supply to Madurai Corporation" Improvement works and system improvement (Phase I&II) Government of India has released Rs.593.16 lakhs and Madurai Corporation has contributed Rs.2177.94 lakhs
- 3. The Chairman and Managing Director, Tamil nadu Urban Finance and Infrasture Development Corporation Ltd, has therefore requested the Government to release both the Central and State share of Rs.3013.53 lakhs. (Government of India share Rs.2497.45 lakhs + Government of Tamilnadu share Rs.516.08 lakhs) towards third instalment for the above two projects.

share Rs.2497.45 lakhs + Government of Tamilnadu share Rs.516.08 lakhs) (Rupees Three thousand thirteen lakhs and fifty three thousand only) towards third installment to the project of "Sea Water Desalination Plant at Minjur" and "Water Supply to Madurai Corporation" – Improvement works and system improvement (Phase I&II).
