ORDER:

The following projects have been approved by the Government of India under the Jawaharlal Nehru National Urban Renewal Mission Scheme. As per the funding pattern of JnNURM the projects get 50% of the project cost as grant from the Government of India and 20% as grant from Government of TamilNadu. The balance 30% of the Project cost will have to be met by the local bodies themselves. The contributions required by the Madurai and Coimbatore Corporations are as follows:
