ORDER:

In G.O.Ms.No.67, Municipal Administration and Water Supply Department, dated 12.8.2006, orders were issued for Administrative Sanction of Second Vaigai Water Supply Scheme to Madurai Corporation at an estimated cost of Rs.59.32 Crores under Jawaharlal Nehru National Urban Renewal Mission. Subsequently in G.O.Ms.No.150, Municipal Administration and Water Supply Department, dated 8.12.2006 orders were issued for sanction and release of Rs.1038.03 lakhs (i.e., Government of India Share Rs.741.45 lakhs + Government of Tamil Nadu Share Rs.296.68 lakhs), as first Instalment

for the year 2006-2007, for the Implementation of Second Vaigai Water Supply Scheme (Phase-I & Phase-II) to Madurai Corporation under Jawaharlal Nehru National Urban Renewal Mission.

2. In his letter third read above, the Chairman & Managing Director, TUFIDCO has stated that in the first and second reference, Government of India had released a sum of Rs.1549.29 lakhs to State Government towards first instalment for the following projects under Jawaharlal Nehru National Urban Renewal Mission. The sanction details are as follows.

The Government after careful examination of the proposal of the Chairman & Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited at para 2 above sanction and release both Central and State Share amounting to Rs.1549.29 Lakhs (Government of India share Rs.1096.85 Lakhs + Government of Tamil Nadu Share Rs.452.44 lakhs) to Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited.

4. The amount sanctioned in Para 3 above shall be debited under the following head of account.

Grants for current expenditure – (2217 05 800 JL 0914)”

5. The Commissioner of Municipal Administration is authorized to draw disburse the amount sanctioned in Para 3 above to TUFIDCO.
