The Corresponding State share is Rs.122.31 lakhs. Under Metropolitan Infrastructure Development Fund maintained by TUFIDCO, Rs.116.48 lakhs was released. The ULB has already contributed Rs.200.00 lakhs on 05.03.2008 for this project.

The Chairman and Managing Director, Tamil nadu Urban Finance and Infrasture Development Corporation Ltd, has therefore requested the Government to release both the Central and State share of Rs.407.70 lakhs. - 4) The Government after careful consideration sanction and release both the Central and State share of Rs.407.70 lakhs. (Government of India share Rs.285.39 lakhs + Government of Tamilnadu share Rs.122.31 lakhs) (Rupees Four hundred seven lakhs and seventy thousand only) towards second installment to the project of "Improvement of Water Supply to Tambaram Municipality
- 5) The amount sanctioned in para 4 above shall be debited to the following head of account.
