The Government after careful consideration sanction and release both the Central and State share of Rs. 1782.45 lakhs Rupees one Thousands Seven Hundred and Eighty Two lakhs and Fourty Five Thousands only towards first installment for Providing comprehensive sewerage facilities for Maduravoyal and Comprehensive water supply scheme to Thiruvottiyur Municipalities.
