In the letter read above the Chairman and Managing Director, Tamilnadu Urban Finance and Infrastructure Development Corporation Ltd has stated that the Government of India had released Rs.5655.78 lakhs for the following projects towards first installment. The details are as follows :-

The Corresponding State share for first Installment works out to Rs.2423.24 lakhs.

3) The Chairman and Managing Director, Tamil nadu Urban Finance and Infrasture Development Corporation Ltd, has therefore requested the Government to release both the Central and State share of Rs.8079.02 lakhs. (Government of India share (Rs.5655.78 lakhs + Government of Tamilnadu share Rs.2423.24 lakhs) for the above projects.

4) A sum of Rs.2872611 Thousand has been provided in FMA 2008-09. A sum of Rs.2000000 Thousand is included in FSE 2008-09 and place before the Legislature on 26.2.2009.

5) The Government after careful consideration sanction and release both the Central and State share of Rs.8079.02 lakhs (Rupees Eight thousand seventy

nine lakhs and two thousands only) towards first installment for the projects mentioned above.

6) The amount sanctioned in para 5 above shall be debited to the following head of account.

8) The Director of Municipal Administration is authorized to draw the amount sanctioned in para 5 above by means of an account payee cheque in favour of Tamil Nadu Urban Finance and Infrastructure Development Corporation Ltd to the P.D.Account (No.01G03099750 BQ) which is in the name of "Tamil Nadu Urban Infrastructure Development and Renewal Fund" and credit the same to the above Deposit account. The amount shall be released after obtaining Administrative Sanction from the competent authority.
