The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has stated that the corresponding State share for first installment works out to Rs.4391.59 lakhs. The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, has therefore requested the Government of Tamil Nadu during the year 2008-09 has released Rs.9541.03 lakhs. They have further sent

- proposal for the release of Rs.10993.41 Lakhs for 11 Projects. The Government of Tamil Nadu has already provided Rs.25000.00 Lakhs in the Budget for the year 2008-09. They have already requested Government of Tamilnadu to provide Rs.487.26 Lakhs in the FSE Instructions have already been issued to ULBs and para-statal agency to obtain Administrative Sanction for the projects.
- 4. The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has therefore requested the Government to release both Central and State share of Rs.14638.64 Lakhs for the above projects and transfer the amount to P.D. Account which is in the name of Tamil Nadu Urban Infrastructure Development and Renewal Fund.
- 5. A sum of Rs.2872611 thousands has been provided in FMA 2008-09 and a sum of Rs.2000000 thousands included in the FSE 2008-09.
- 6. The Government after careful consideration sanction and release both the Central and State share of Rs.14638.64 Lakhs towards first installment for Tambaram, Ambattur Municipalities and Chennai Corporation SWD-Eastern Basin and Southern Basin.
- 7. The amount sanctioned in para-4 above shall be debited to the following head of account:-
- " 2217- Urban Development-05. Other Urban Development Schemes-800. Other Expenditure- Schemes in the Eleventh Five Year Plan-II State Plan-JL. Jawaharlal Nehru National Urban Renewal Mission (JNNURM) Sub-Mission for Urban Infrastructure and Governance-09 Grants-in Aid-01 Grants for Current Expenditure (DPC 2217 05 800 JL 0914).
- 8. The amount shall not be paid in cash, but credited to the following Head of Account:-
- "8443.00 Civil Deposits- 800 Other Deposits BW- Deposits of Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited (TUFIDCO) (DPC 8443 00 800 BW 000C (Receipts)

- 9. The Director of Municipal Administration is authorized to draw the amount sanctioned in para 5 above by means of an account payee cheque in favour of Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited to the P.D. Account (No.01 G03099750 BQ) which is in the name of "Tamil Nadu Urban Infrastructure Development and Renewal Fund" and credit the same to the above Deposit account. The sanctioned amount shall be released from the P.D. Account after obtaining the necessary Administrative sanction.
