### ORDER:

The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited in his letter read above has stated that they have sent Utilization Certificates to Government of India under Urban Infrastructure Development Scheme for Small and Medium Towns (UIDSSMT) for accessing, second instalment funds of Rs.14305.24 lakhs for 60 projects of 59 towns. However, in letter F.No.59(3)/PF-1/2008-284, dated 26.9.2008, the Government of India has released second instalment funds of Rs.8949.70 lakhs for 40 projects of 39 towns. The balance of second instalment fund of Rs.5355.54 lakhs for 20 towns are awaited. The second instalment of Government of Tamil Nadu's matching share of 40 projects of 39 towns is Rs.1118.71 lakhs.

2. The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has therefore requested the Government to release the second instalment of Government of India's share along with Government of Tamil Nadu's matching share amounting to

Rs.10068.41 lakhs (Rs.8949.70 + 1118.71lakhs) (Rs.one hundred crore sixty eight lakhs and forty one thousand only) to TUFIDCO for the 40 projects of 39 towns so as to enable them to release the balance amount to the concerned ULBs for completion of projects/settlement of bills.

3. The Government, after careful examination of the proposal of the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited at para 2 above and sanction and release the second instalment of both the Central and State Government's share amounting to Rs.10068.41 lakhs (8949.70 +1118.71 lakhs) (Rs.one hundred crore sixty eight lakhs and forty one thousand only) to Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited for the 40 projects of 39 towns under UIDSSMT as detailed in the Annexure to this order.

4. The amount sanctioned in para 3 above shall be debited under the following head of account.

6. The Director of Municipal Administration is authorized to draw the amount sanctioned in para 3 above by means of an account payee cheque in favour of Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited to the P.D. Account which is in the name of “Tamil Nadu

Urban Infrastructure Development and Renewal Fund” and credit the same to the above Deposit account.
