ORDER:

The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited in his letter read above has stated that the Government of India had released 1st installment of Rs.1407.24 lakhs for 3 projects of 3 towns under Urban Infrastructure Development Scheme for Small and Medium Towns (UIDSSMT). The 1st installment of Government of Tamil Nadu's matching share of 3 projects of 3 towns is Rs.175.91Lakhs.

2. The Chairman and managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has therefore requested the Government to release the 1st installment of Government of India's share along with Government of Tamil Nadu's matching share amounting to Rs.1583.15 lakhs (Rs.1407.24+ 175.91 lakhs), (Rupees Fifteen Crores Eighty Three lakhs and Fifteen thousand only) on the following basis.

The Government after careful examination of the proposal of the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited at para 2 above and sanction and release the 1st installment of both the Central and State Government's share amounting to Rs.1583.15 lakhs (Rs1407.24 lakhs+ Rs.175.91lakhs), (Rupees Fifteen crores Eighty three lakhs and Fifteen thousand only) to Tamilnadu Urban Finance and Infrastructure Development Corporation Limited for the 3 projects of 3 towns under UIDSSMT.

3. The amount sanctioned in para-3 above shall be debited under the following head of account:-

Account after obtaining Administrative Sanction from the competent authority.
