ORDER:

The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited in his letter read above has stated that the Government of India released 2nd installment of Rs.6527.86lakhs for 27 projects of 27 towns under Urban Infrastructure Development Scheme for Small and Medium Towns (UIDSSMT). The Second installment of Government of Tamil Nadu's matching share of 27 projects of 27 towns is Rs.815.98 Lakhs.

2. The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has therefore requested the Government to release the second installment of Government of India's share along with Government of Tamil Nadu's matching share amounting to Rs.7343.84 lakhs (Rs.6527.86 + 815.98 lakhs), (Rupees Seventy Three crores Forty three lakhs and Eighty Four thousand only) to TUFUDCO for the 27 projects of 27 towns so as to enable them to release the balance amont to the concerned ULBs for completions of projects/ settlement of bills.

- 3. The Government after careful examination of the proposal of the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited at para 2 above and sanction and release the second installment of both the Central and State Government's share amounting to Rs.7343.84 lakhs (Rs.6527.86 lakhs+ Rs.815.98lakhs), Rupees Seventy Three Crores Forty three lakhs and Eighty Four thousand only) to Tamilnadu Urban Finance and Infrastructure Development Corporation Limited for the 27projects of 27 towns under UIDSSMT as detailed in the Annexure to this order.

- 4. The amount shall not be paid in cash, but credited to the following Head of Account:-
 - "8443.00 Civil Deposits-800 other deposits BW- Deposits of Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited (TUFIDCO) (DPC 8443 00 800 BW 000C (Receipts)
- 5. The Director of Municipal Administration is authorized to draw the amount sanctioned in para 3 above by means of an account payee cheque in favour of Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited to the P.D.Account which is in the name of "Tamil Nadu Urban Infrastructure Development and Renewal Fund" and credit the same to

the above Deposit account. The sanctioned amount of Rs.7343.84 lakhs shall be released from the P.D. Account after obtaining Administrative Sanction from the competent authority.
