#### **ORDER:**

In the letter read above, the Director of Municipal Administration has stated that the Detailed Project Report prepared by M/s. Mott Mac Donald Private Limited, Chennai for Construction of Storm Water Drain in three phases at an estimated cost of Rs. 109185.60 lakhs have been placed before the State Level Sanctioning Committee Meeting and the DPR have been forwarded to the Government of India by the Nodal Agency Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited for placing it before the Central Sanctioning and Monitoring Committee. The Central Sanctioning and Monitoring Committee meeting held on 28.08.2009 has restricted and approved the project for a cost of Rs. 18000.00 lakhs under Phase – I covering 32 zones including Central Government Assistance of Rs. 9000.00 lakhs subject to the condition that the project should be completed in 18 months from October 2009.

- 2. The Director of Municipal Administration further stated that based on the approval of the Central Sanctioning and Monitoring Committee, in the Ir. no. 81/JNNURM/M(Mu)/2009, dated 23.09.2009, the Nodal Agency has sanctioned loan towards 30% share of the ULB contribution on the project cost.
- 3. The Director of Municipal Administration has further stated that as per the Loan-cum-grant sanction letter issued by Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited the funding pattern for the scheme is as detailed below:-

- 4. The Director of Municipal Administration has therefore requested the Government to accord administrative sanction for the scheme for Construction of Road Side Storm Water Drain (Phase I) to Coimbatore Corporation at an estimated cost of Rs. 18000.00 lakhs.
- 5. The Government after careful examination accord administrative sanction for the scheme for construction of Road Side Storm Water Drain (Phase I) at an estimated cost of Rs. 180.00 crores (Rupees one hundred and eighty crores only) to Coimbatore Corporation with the following funding pattern:-
- (i) Government of India Contribution Rs. 90.00 crores (50%)
- (ii) Government of TamilNadu Rs. 36.00 crores Contribution (20%)
- (iii) ULB/ Financial Institution (30%) Rs. 54.00 crores

Total - Rs. 180.00 crores
