ORDER:

The Tamil Nadu Municipal Corporations Service Rules, 1996 came into effect from 1-10-1996 and is applicable to all the Corporations except Chennai. The Director of Municipal Administration in his letter second read above has proposed certain amendments to the rules relating to filling up the post of Assistant Commissioner (Ward Office) in Part-III, Special Rules, for the Tamil Nadu Municipal Corporations General Service Rules, 1996.

2. The Government have carefully examined the proposal of the Director of Municipal Administration and decided to accept the same. Accordingly, the Government have decided to amend the rule 3 of the Special Rules for the Tamil Nadu Municipal Corporations General Service Rules, 1996 relating to filling up the post of Assistant Commissioner (Ward Office) in Part-III, Special Rules, for the Tamil Nadu Municipal Corporations General Service Rules, 1996.

3. The appended Notification shall be published in the Tamil Nadu Government Gazette.
