### ORDER:

While moving the Demand for the year 2006-07, the Hon'ble Minister for Rural Development & Local Administration had announced in the Legislative Assembly that a comprehensive water supply scheme will be taken up for Nerkundram Village Panchayat. The Government, in D.O. Lr. No.81/ Secy./ MA&WS/2007, dt.31.10.2007, the Managing Director, Chennai Metropolitan Water Supply and Sewerage Board was requested to send a proposal to Government of India for implementation of the water supply scheme for Nerkundram Village under JNNURM with the following funding pattern:-

Accordingly, the Managing Director, Chennai Metropolitan Water Supply and Sewerage Board has prepared a Detailed Project Report for Rs.19.22 Crores.

2. The M.D., CMWSSB has further stated that this scheme was placed before the CSMC (Central Sanctioning & Monitoring Committee) under JNNURM during its meeting held on 18.01.2008 and the CSMC has approved the scheme.

3. The Managing Director, CMWSS Board has also stated that since the TWAD Board is the nodal agency of the Government to implement the water supply schemes under "Minimum Needs Program" in village panchayats, Tamil Nadu Water Supply and Drainage (TWAD) Board was requested in his letter dt.14.9.2007 to obtain the approval of the Government to meet 30% of the scheme cost of Rs.22.40 crores under "Minimum Needs Program". In the letter dt.19.11.2007, the Managing Director, TWAD Board has requested the Managing Director, CMWSS Board to approach the Government for getting funds under Minimum Needs Programme (MNP). Accordingly as per the letter dt.28.11.07, Government were addressed to provide 30% of scheme cost under MNP.

4. The Managing Director, CMWSS Board in his letter dated.03.01.2009 has stated that a DPR for providing comprehensive water supply scheme to Nerkundram Village Panchayat was posed to JNNURM and that the Central Sanctioning and Monitoring Committee of the Government of India in it's meeting held on 18.01.2008 sanctioned the scheme for Rs.19.17 crores with certain conditions about the status of the local body. The Government of Tamil Nadu had indicated the funding pattern for this scheme as follows:-

5. The Managing Director, CMWSS Board has requested the Government to sanction necessary funds for implementing Comprehensive Water Supply Scheme to Nerkundram Village panchayat under MNP and from out of the funds available with CMDA/Housing & Urban Development Department, so as to meet their respective shares as indicated in para 4 above and also to accord administrative sanction for Rs.19.17 crores for this scheme.

6. The Housing and Urban Development Department has issued orders in Lr.(Ms.) No.18, dt.2.2.2010 directing the Member Secretary, Chennai Metropolitan Development Authority, to place the subject Viz., provision of funds to an extent of Rs.3.83 crore towards 20% - share of the local body Nerkundram Village Panchayat, in the forthcoming Authority Meeting of Chennai Metropolitan Development Authority to give its consent for release of said funds from the funds

of Chennai Metropolitan Development Authority to Chennai Metropolitan Water Supply and Sewerage Board towards implementation of comprehensive water supply scheme in Nerkundram Village.

7. The Government after careful examination accept the request of the Managing Director, CMWSS Board and accord administrative sanction for implementation of the comprehensive water supply scheme in Nerkundram Village Panchayat at a total cost of Rs.19.17 crores on the funding pattern mentioned at para 4 above subject to the following conditions:-

- (i) the CMDA has to pass necessary resolution for release of Rs.383.40 lakhs from its funds for the said project towards 20% contribution of the local body.
- (ii) action has to be taken to upgrade the Nerkundram Village panchayat to that of a ULB / amalgamating the same with Chennai Corporation; and
- (iii) a sum of Rs.575.10 crores being 30% of the cost may be met from the MNP funds provided to TWAD Board.

8. This order issues with the concurrence of Finance Department vide its U.O. No.6524/Fin(MAWS)/2010, dt.25.2.2010.
