ORDER:

In the letter 5th read above, the Director of Municipal Administration has stated that Basic Services to the Urban Poor (BSUP) and Integrated housing and slum development programme (IHSDP) are important sub-missions under the Jawaharlal Nehru National Urban Renewal Mission(JNNURM), which is a Centrally sponsored programme. In Tamil Nadu, Chennai, Coimbatore and Madurai (including the Urban Local Bodies in their urban agglomeration Area) are covered under the BSUP. The remaining towns are covered under the IHSDP scheme. Under both these programmes, housing for the urban poor (in-situ as well as relocation) and slum infrastructure up gradation works have been taken up.

2. The Director of Municipal Administration has also stated that, in the Government Orders 1st /2nd /3rd read above, among others, the Government has sanctioned and released 1st instalment of Government of India share and Government of Tamil Nadu share to the following Urban Local Bodies.
