APPENDIX

NOTIFICATION

In exercise of the powers conferred by section 430 of the Coimbatore City Municipal Corporation Act, 1981 (Tamil Nadu Act 25 of 1981), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Urban Local Bodies Licensing of Hoardings and Levy and collection of Advertisement Tax Rules, 2003:-

AMENDMENTS

In the said Rules, in rule 6,

(1) The following proviso shall be added to sub-rule (1), namely:-

Provided that in respect of a hoarding to be erected upon a bus shelter and public convenience built by Coimbatore City Municipal Corporation, the maximum size shall be 3 metres X 9 metres (Horizontal Position) irrespective of the width of the road.

(2) after sub-rule (6), the following sub-rule shall be added, namely:-

“(7) Nothing contained in sub-rules (3) and (6) shall apply to any hoarding erected upon a bus shelter, and public convenience built by Coimbatore City Municipal Corporation. Provided such hoardings shall be erected after leaving sufficient space for the use of pedestrians”.
