ORDER:

In the Government Order 1st read above, the Government have accorded Administrative sanction to Tamil Nadu Slum Clearance Board for construction of 5000 new houses at various places in Tamil Nadu.

2. In the letter fifth read above the Director of Municipal Administration has stated that the State Level Co-ordination Committee (SLCC) in the meeting held on 27.8.2008 has approved revision in construction of 5000 units to 4343 units. The Director of Municipal Administration has also stated that the Government of India in the 63rd CSC meeting has approved the reimbursement of expenditure in VAMBAY projects to the State of TamilNadu and subsequently sanctioned ancillary pecuniary support from the IHSDP allocation to the Tamil Nadu Slum Clearance Board as detailed below.

3. In the letter third read above, interalia, The Government of India has released balance amount of Rs.342.85 lakhs out of the approved Central share of Rs.922.85 lakhs towards ongoing VAMBAY projects of IHSDP allocation.

4. The Director of Municipal Administration has therefore requested the Government to release the Central Share of Rs. 342.85 lakhs to the Tamil Nadu Slum Clearance Board through SLNA for the said project.

5. The Government after careful examination, accept the proposal of the Director of Municipal Administration, sanction and release of a sum of Rs. 342.85 lakhs (rupees Three crore forty two lakhs and eighty five thousand only) to the Tamil Nadu Slum Clearance Board through SLNA.

6. The amount sanctioned in para 5 above shall be debited for the following head of account.
