ORDER:

In the letter 7th read above, the Director of Municipal Administration has stated that the Basic Services to the Urban Poor (BSUP) and Integrated housing and slum development programme (IHSDP) are important sub-missions under the Jawaharlal Nehru National Urban Renewal Mission(JnNURM), which is a Centrally sponsored programme. In Tamil Nadu, Chennai, Coimbatore and Madurai (including the Urban Local Bodies in their urban agglomeration Area) are covered under the BSUP. The remaining towns are covered under the IHSDP scheme. Under both these programmes, housing for the urban poor (in-situ as well as relocation) and slum infrastructure up gradation works have been taken up.

2) The Director of Municipal Administration has also stated that, the Government Order 1st to 4th read above, the Government has sanctioned and released 1st installment of central and State share to the following urban local bodies along with certain other ULBs

3) The Director of Municipal Administration has also further stated that in the reference 5th read above, the Ministry of Housing and urban poverty alleviation have sanctioned additional central assistance as 2nd installment under IHSDP scheme to the above said ULBs and in the reference 6th read above, the Ministry of Finance, Department of Expenditure has released the total amount of Rs.3408.47 lakh as 2nd installment for the above said urban local bodies.

5)The Director of Municipal Administration has therefore requested the Government to sanction & release the Central & State share of **Rs.4278.625 lakh (3408.47 + 870.155)** to the above said 23 ULBs as 2nd installment for the year 2009-2010 under Integrated Housing and Slum Development Programme [IHSDP) scheme.

6) The Government after careful consideration, accept the proposal of the Director of Municipal Administration at para 5 above, Accordingly sanction and release an amount of **Rs. 4278.625 lakh (Rupees Forty two crore seventy eight lakhs sixty two thousand five hundred only)** being Central and State share for the implementation of the Integrated housing and slum development programme [IHSDP] scheme in the above said 23 ULBs.
