



### ABSTRACT

Part II Scheme for 2006 – 07 – Water Supply – Improvement of Water Supply Schemes to 38 financially weaker Municipalities – alternative works instead of Replacement of motors/pumpsets in respect of 10 Municipalities – Revised – Orders - Issued.

### ORDER:

In the Government order first read above, orders were issued sanctioning an expenditure of Rs. 398.50 lakhs under Part II Scheme for the year 2006 – 2007 for replacement of old motors/ pumpsets for improving the efficiency of the existing water supply schemes in 38 financially weaker Municipalities listed out in the annexure to the order.

2. The Commissioner of Municipal Administration has stated that out of these 38 Municipalities , works have been completed in 9 Municipalities, works under progress and are in various stages in 19 Municipalities. The remaining 10 urban local bodies have come up with proposals to take up improvements to distribution main system or for collection well work in modification of the works originally sanctioned. He has added that these urban local bodies have already completed the repairs to motors / pumpsets from their own funds & require distribution main work to be done now under the Part - II scheme.

3. He has therefore requested orders of Government to permit the

following 10 urban local bodies to take up the alternative works as mentioned below:-


