# ORDER:

In the letter fourth read above the Director of Municipal Administration has stated that, the Government of India has sanctioned 2<sup>nd</sup> instalment of Rs.1267.76 lakhs to Chennai Corporation and 1<sup>st</sup> instalment of Rs.2168.65 lakhs to Coimbatore Corporation (Phase-III) at Ukkadam. The details are furnished below:

The Director of Municipal Administration has therefore requested to release the amount sanctioned by Government of India as first installment of Rs.2168.65 lakhs and the equivalent State Share of Rs.2093.49 lakhs, totally Rs.4262.14 lakhs to Coimbatore Corporation (Phase III) at Ukkadam and Government of India share of Rs.1267.76 lakhs as 2<sup>nd</sup> instalment to Chennai Corporation and corresponding State share of Rs.1706.71 lakhs totally Rs.2974.47 lakhs. He has also requested the Government release a sum of Rs.2974.47 lakhs (Government of India and Government of Tamil Nadu share) to Chennai Corporation as 2<sup>nd</sup> instalment and a sum of Rs.4262.14 lakhs (Government of India and Government of Tamil Nadu share) to Coimbatore Corporation (Phase III) at Ukkadam as first instalment totally Rs.7236.61 lakhs (Rs.2974.47 lakhs + Rs.4262.14 lakhs = Rs.7236.61 lakhs).

3. The Government after careful consideration sanction and release a sum of Rs.2974.47 lakhs (Government of India and Government of Tamil Nadu Share) towards assistance for projects in Chennai Corporation as 2<sup>nd</sup> installment and a sum of Rs.4262.14lakhs (Government of India and Government of Tamil Nadu share) to Coimbatore Corporation (Phase III) at Ukkadam as first installment totaling to Rs.7236.61 lakhs (Rs.2974.47 lakhs + Rs.4262.14 lakhs = Rs.7236.61 lakhs)

Jawaharlal Nehru National Urban Renewal Mission (JNNURM) Basic Services to Urban Poor -Special Component Plan for Schedule Castes controlled by Commissioner of Municipal Administration 09. Grants-in-aid – 01- Grants for current expenditure. (D.P.Code No.2217 04 789 JH - 0918)".

The Director of Municipal Administration is authorized to draw the amount to Urban Local Bodies by means of cheque to be drawn in favour of Director of Municipal Administration's Basic Services to the Urban Poor Account No.30120509278. The above amount would be released from the Basic Services to the Urban Poor account only after obtaining administrative sanction orders from the competent authority.
