ORDER:

The Government of India has launched three new schemes namely

- 1) JNNURM with 2 sub-components namely:
  - a) Submission on Urban Infrastructure & Governance
    - b) Submission on Basic Services for the Urban Poor
- 2) UIDSSMT (Urban Infrastructure Development Scheme for Small and Medium Towns)
- 3) IHSDP (Integrated Housing and Slum Development Programme.

In the Government Order, second read above, Government have sanctioned and released a sum of Rs.68.31 crores (Rupees Sixty Eight Crores and Thirty One Lakhs only ) towards State Share under under Submission on Basic Services for the Urban Poor (BSUP) for the year 2006-07.

2. The Commissioner of Municipal Administration in his letter third read above has stated that as per the guidelines of BSUP, Central Share would be released to the State Government or its designated State level agencies. The Commissioner of Municipal Administration has also stated that the proposal was sent from his office for release of state share for the above schemes in the presumption that the central share would be received in the Commissionerate of Municipal Administration directly. But it is seen from the Government of India sanction order taken from website, that a sum of Rs.8299.58 lakhs (Rupees Eighty Two Crores ninety nine lakhs and fifty eight thousands only)

has been received by the Government of Tamil Nadu against the total project cost of Rs.82036.38 lakhs. The commitment of central and State Government is given below:

- 3. The Commissioner of Municipal Administration has further stated that the Government of India has released 25% of it's share as Ist instalment in the year 2006-2007. As per the above statement, State Government has to release Rs.7885.73 lakhs (Rupees seventy eight crores eighty five lakhs and seventy three thousands only) as its 25% of share. But an amount of Rs.6831 lakhs (Rupees sixty eight crores and thirty one lakhs only) has been released by State Government in the G.O.(D)No.143, Municipal Administration and Water Supply Department, dated 30..0.2007.
- 4. The Commissioner of Municipal Administration has, therefore, requested the Government that the balance amount of (Rs.7885.73 lakhs 6831.00 lakhs) Rs.1054.73 lakhs (Rupees Ten crores fifty four lakhs and seventy three thousands only) may be released as state share for the year 2006-2007.
- 5. The Government, after careful consideration, accept the proposal of Commissioner of Municipal Administration at para 4 above and sanction and release an amount of Rs.1054.73 lakhs (Rupees Ten Crorers Fifty Four Lakhs and Seventy Three thousand only) being the state share for the above schemes under Jawaharlal Nehru National Urban Renewal Mission.
- 6. The amount sanctioned in para 5 above shall be debited in the following head of account.

"2217 – Urban Development – 04 – Slum Area Improvement – 192. Assistance to Municipalities / Municipal Councils – II State Plan – JC. Jawaharlal Nehru Urban Renewal Mission (JNNURM) – Submission for Basic Services to Urban Poor Controlled by Commissioner of Municipal Administration – 09. Grants in aid – 02 Grants for capital Expenditure – (D.P.Code 2217 04 192 JC 0923)".

7. The Commissioner of Municipal Administration is authorized to draw and disburse the amount to Urban Local Bodies / Tamil Nadu Slum Clearance Board.
