ORDER:

- 1. In the letter third read above the Commissioner of Municipal Administration has stated that in G.O.(D)No.143, Municipal Administration and Water Supply Department, dated 30.03.2007 have sanctioned and released a sum of Rs.6831.00 lakhs towards state share under the Basic Services to the Urban Poor for the year 2006-2007 and in G.O.(D)No.357, Municipal Administration and Water Supply Department, dated 01.06.2007 have sanctioned and released the balance amount of Rs.1054.73 lakhs under the Basic Services to the Urban Poor. So far an amount of Rs.7885.73 lakhs has been released by the State Government as its share. The Government of India share of Rs.8299.58 lakhs has not been released so far.
- 2. The Commissioner of Municipal Administration has further stated that a sum of Rs.8299.58 lakhs has been received by the Government of Tamil Nadu against the total project cost of Rs.83026.38 lakhs. So far, the State Government has released a sum of Rs.7885.73 lakhs as state share. The Government of India's share of Rs.8299.58 lakhs is still awaited from the Government of Tamil Nadu. He has therefore requested the Government to release the Government of India amount Rs.8299.58 lakhs immediately so as to implement the projects expeditiously.
- 3. The Government after careful consideration, accept the proposal of the Commissioner of Municipal Administration at para 2 above and release an amount of Rs.82,99,58,000/- (Rupees Eighty two crores ninety nine lakhs and fifty eight thousands only) for the scheme of Basic Services to the Urban Poor under Jawaharlal Nehru National Urban Renewal Mission.

- 4. The amount sanctioned in para 3 above shall be debited in the head of account:
 - "2217 Urban Development 04. Slum Area Improvement 192. Assistant of Municipalities / Municipal Councils Schemes in Eleventh Five Year Plan II State Plan JC Jawaharlal Nehru Urban Renewal Mission (JNNURM) Submission for Basic Services to Urban Poor Controlled by Commissioner of Municipal Administration 09. Grants in aid 02. Grants for Capital Expenditure. (DP Code 2217 04 192 JC 0923)"
- 5. Necessary funds will be provided in the R.E. / FMA 2007-08 and pending provision of such funds. The Commissioner of Municipal Administration is authorised to draw and disburse the amount to Urban Local Bodies / Tamil Nadu Slum Clearance Board, and also requested to send necessary proposals to Government for inclusion in R.E./FMA 2007-08 at an appropriate time.
- 6. This order issues with the concurrence of Finance Department vide its U.O.No.57549/MAWS/07, dated 18.09.2007 and ASL No.941 (Nine Hundred and forty One).
