ORDER:

1. In the letter third read above, the Commissioner of Municipal Administration has stated that in his Letter dated 23.03.2007 revised proposals has been sent to Government seeking State share of Rs.40.00 crores under Integrated Housing and Slum Development Programme Scheme and also stated that it is expected that the Government of India will sanction some more proposals shortly.

2. The Commissioner of Municipal Administration has now requested the Government to release the additional grant of Rs.10.00 crores as proportionate State Share for the implementation of Integrated Housing and Slum Development Programme Scheme.

3. The Government after careful consideration accept the proposal of the Commissioner of Municipal Administration sanction and release a sum of Rs.10.00 crores as proportionate state share for the implementation of the IHSDP scheme.

4. The amount sanctioned in para 3 above shall be debited in the following head of account.

“2217. Urban Development – 04. Slum Area Improvement – 789. Special Component Plan for Schedule Castes – JG. Integrated Housing and Slum Development Programme (IHSDP) -09. Grants in aid -02. Grants for Capital Expenditure – DP Code 2217 04 789 JG 0920.”

5. The Commissioner of Municipal Administration is authorized to draw and disburse the amount sanctioned in para 3 above for the above scheme to the Urban Local Bodies.
