ORDER:

1. In G.O.(D).No.600, Municipal Administration and Water Supply Department, dated 11.12.2007, orders were issued for sanction and release of balance amount of a sum of Rs.223.12 for the IHSDP for the year 2006-2007.

2. The Commissioner of Municipal Administration in his letter fourth cited has stated that it is seen from the Government of India sanction order that the central share has been released to Government of Tamil Nadu with a direction to release the same along with the state share to the Nodal Agency. The details of particulars are furnished below for the lease of balance amount of central and state share for the year 2006-2007.

vi)	Balance to be released for the year 2006-2007 for IHSDP scheme (GOI Rs.1290.20 lakhs + GOTN state share Rs.264.51 lakhs)	1554.71

3. The Commissioner of Municipal Administration has therefore requested that the Government of India share of Rs.1290.20 lakhs and the state share of Rs.264.51 lakhs together with a total amount of Rs.1554.71 lakhs may be released to implement the IHSDP scheme to the ULBS.

4. The Government after careful consideration sanction and release a sum of Rs.1554.71 lakhs for the Integrated Housing and Slum Development Programme for the year 2006-2007.

5. The amount sanctioned in para 4 above shall be debited in the following head of account.

“2217 – Urban Development 04 – Slum Area Improvement 789 – Special Component Plan for Schedule Castes JG. Integrated Housing and Slum Development Programme (IHSDP)-09. Grants-in-Aid 02 – Grants for Capital Expenditure (DP Code 2217 04 789JG 0920)” Rs.310.94 lakhs.

6. The Commissioner of municipal Administration is authorized to draw and disburse the amount sanctioned in para 4 above for the above scheme to the Urban Local Bodies.
