ORDER:

In G.O.(Ms) No.202, Municipal Administration and Water Supply Department dated 2.8.1994, the Collector of The Nilgiris, Dindigul and Salem

Districts were authorised to exercise the powers vested with the State Government, under the provisions of Section 217-J of Tamil Nadu District

Municipalities Act, 1920 in respect of the Hill Stations under their control.

2. Accordingly, the Collector, Dindigul District has taken action against the unauthorised construction in Kodaikanal Municipality . Most of the owners of the buildings have filed writ petitions and obtained stay orders against the action taken by the Collector and Municipal Commissioner, Kodaikanal Municipality. Therefore, the Collector, Dindigul District had requested the Government to permit the advocates Thiruvalargal. E. Padmanabhan and Srinivasan Who were regularly appearing for the Kodaikanal Municipality, to appear on behalf of the Collector also as the subject of the cases are same. Accordingly, orders were issued in the G.O. first read above appointing advocates to appear on behalf of the Collector of Dindigul district & Commissioner of Kodaikanal Municipality.

3. As Thiru E. Padmanabhan has been appointed as High Court Judge, the Collector of Dindigul District, in his letter second read above has requested that Thiru V. Radhakrishnan, Senior Advocate in High Court of Madras may be appointed as Counsel for the Kodaikanal Municipality as well as for the Collector of Dindigul, to deal with the cases pertaining to the buildings in the Kodaikanal Municipality and file common counter affidavits on behalf of both.

4. The Government have carefully examined the request of the Collector of Dindigul District and they direct that Thiru V. Radhakrishnan, Senior Advocate, High Court of Madras be appointed to enter appearance on behalf of the Collector, Dindigul District and the Commissioner of Kodaikanal Municipality in the cases filed against them in exercising the powers under the provisions of Chapter X - A of the Tamil Nadu District Municipalities Act, 1920, by the owners of unauthorized constructions in the hill areas of the District and also file common counter affidavits on their behalf.
