ORDER:

In the G.O. read above the Government have sanctioned a sum of Rs.41.1487 (Rupees Forty one crores fourteen lakhs and eighty seven thousand only) crores towards release of 1st instalment of local body grants recommended by the Twelfth Finance Commission for the year 2008-2009 to the Commissioner of Municipal Administration for distribution to all Municipal Corporations and Municipalities including Grade-III Municipalities.

- 2. The Commissioner of Municipal Administration in his letter read above has requested the Government to release the balance 50% of the grant as second instalment as per the Budget estimate for the year 2008-2009.
- 3. The Government, after careful examination and in anticipation of the receipt of second instalment from Government of India, sanction and release the second instalment grant for the year 2008-2009 as follows:-

- 4. The distribution among various municipalities shall be made by giving 75% weightage to population (2001 census) and balance 25% weightage to financial parameters.
 - 5. The amount sanctioned in para 3 above shall be utilized as below:-
 - (a) 50% for the scheme of Solid Waste Management through Public Private Partnership. The Municipalities should concentrate on collection, segregation and transportation of Solid Waste. The cost of these activities whether carried out in-house or out-sourced could be met from the grants.
 - (b) 25% of the grant for conversion of earthern / metal road into BT/CC road and for the formation of storm water drains wherever required.
 - (c) 25% for miscellaneous works such as creation of data base, payment of electricity charges etc.
- 6. The Commissioner of Municipal Administration is requested to ensure that the 50% of the grants sanctioned in para 3 above are utilized only for the schemes of Solid Waste Management and the balance 50% shall be utilized for the purposes as mentioned in para 5(b) and (c) above.
- 7. Necessary provisions have been made in the Budget Estimate 2008-2009. The Director of Municipal Administration is authorized to draw and disburse the amount sanctioned in para 3 above to all Municipal Corporations / Municipalities / IIIrd Grade Municipalities.
- 8. The Director of Municipal Administration is also requested to furnish the Utilisation Certificates for the utilisation of the amount sanctioned in para 3 above to the Government in the format prescribed by Government of India so as to forward the same to the Government of India.
- 9. The expenditure sanctioned in para 3 above shall be debited to the following heads of account:-

<u>For Municipalities:</u> (Rs.19,44,80,000/-) (Rupees Nineteen crores forty four lakks and eighty thousand only).
