**ORDER:-**

In the Government Order first read above, the existing one post of Superintending Engineer created in G.O.(Ms) No.980, Rural Development & Local Administration Department, dated 28.05.1981 in the Commissionerate of Municipal Administration, governed by Tamil Nadu Municipal Engineering Service Rules, 1997 was upgraded to the post of Chief Engineer.

- 2. In the Government Order second read above, Thiru R. Raghunathan, Superintending Engineer, Commissionerate of Municipal Administration (on deputation under Foreign Service) was promoted to the upgraded post of Chief Engineer in the Commissionerate by deputation under foreign service on contract basis and joined duty on 30.07.2008.
- 3. The appointment of Thiru R. Raghunathan in the post of Chief Engineer in the Commissionerate of Municipal Administration has to be treated as deputation under foreign service on contract basis, as per rule 39 (c) of Part-II of General Rules for the Tamil Nadu State and Subordinate Service Rules, substituted in G.O.Ms.No.21, Personnel and Administrative Reforms (S) Department, dated 23.01.1996 from the date of assumption of the charge in the present post till the date of his relief. The above appointment will be governed by the following terms and conditions:-
- i) The appointment as Chief Engineer will be for a period of three years from the date of relief from the post of Superintending Engineer in the Commissionerate of Municipal Administration.
- ii) He will draw eligible pay and allowances, as admissible to the post held by him in the foreign body.
- iii) He shall be deemed to be a member of the parent body for the purpose of the disciplinary rules under the Tamil Nadu Coimbatore City Municipal

Corporation Service (Discipline and Appeal) Rules, 1986, which is applicable to the staff of Tirunelveli City Municipal Corporation. Notwithstanding the fact that his services are placed at the disposal of the Government, if he commits any act of omission or commission, which makes him liable to the penalty specified in the said rules, the foreign body shall be the competent authority to initiate disciplinary proceedings against him and to impose such penalties on him, specified in the relevant said rules, during deputation.

- iv) The foreign body shall recover the subscription of Provident Fund every month from his pay at the rate specified by the Government from time to time and remit it to his parent body i.e., Tirunelveli City Municipal Corporation.
- v) The foreign body will not pay any contribution towards gratuity. The gratuity contribution shall be borne only by the parent body for the period of deputation.
- vi) The foreign body shall sanction the leave salary contribution at the time of termination of the deputation period, after deducting the actual earned leave availed. If the earned leave applied for in a year, while on deputation exceeds the leave salary contribution that would accrue for the tenure of period mentioned in the appointment, first the foreign body shall bear the entire leave salary for the excess earned leave period and then his parent body shall bear the liability by reimbursing the amount to the foreign body.
- vii) Regarding reimbursement of medical expenditure, it may be left out to his option, either from the foreign body or from the parent body, subject to the stipulation that the option once exercised shall be final for the entire service of deputation, following the relevant rules from time to time.
- viii) The pension contribution shall be met out by the foreign body in the event of appointing him in the foreign service by deputation on contract basis as per the General Rules for the Tamil Nadu State and Subordinate Services Rules.
