ORDER:

In the letter fourth read above, the Director of Municipal Administration has stated that in G.O. (D) Mo. 153, MAWS Department, dated 31.3.2010, the Government has released cumulative central and state share of Rs.4147.39 lakh out of the claim of Rs.12288.29 lakh to the 17 ULBs, as 2nd, 3rd and 4th installment for the year 2009-10 and also directed to send necessary proposals for the balance cumulative central and state amount of Rs.8140.9 lakh for the above said 17 ULBs, as 2nd, 3rd and 4th installment under BSUP scheme in the year 2010-11.

2. The Director of Municipal Administration has also stated that, in the letter second read above, the Government of India have sanctioned Rs.219.38 lakh to the 3 ULBs under BSUP Scheme and the corresponding state share for 3 ULB is Rs.182.22 lakh (**Total Rs. 219.38 + Rs. 182.22= Rs.401.60 lakh**).

3. The Director of Municipal Administration has therefore requested the Government to release the balance cumulative central and state amount of Rs.8140.90 lakh pertaining to the 17 ULBS and also to sanction and release

Rs.401.60 lakh to the 3ULBs (apart from 17 ULBs) 2nd instalment totally Rs.8542.50 lakh as detailed below:
