Part II Scheme 2010-11 Construction of office building for Regional Director of Municipal Administration at Tiruppur and Salem – Sanction of Rs.275.00 lakhs (Rupees Two hundred and Seventy five lakhs only) – Orders –Issued.

ORDER:

The Director of Municipal Administration in his letter read above has stated that there are Seven Regional Directorates at Chengalpattu, Salem, Tiruppur, Vellore, Thanjavur and Tirunelveli being functioning under the control of Director of Municipal Administration. Out of this, Vellore and Salem Regional Offices are housed in their own building. Construction of office Buildings for Regional Offices at Madurai and Tirunelveli had been sanctioned under part II Scheme for the year 2009-2010. The Tiruppur Regional Office is housed in the first floor of Kumaran shopping complex owned by the Tiruppur City Municipal Corporation. Though the Salem Regional Office is functioning in their own building at present, the building is not spacious to accommodate all officers and staff. Further the building has become old and requires major repair/maintenance work. Hence during the year 2010-11, it is proposed to construct office buildings for Tiruppur and Salem Regional Directorates of Municipal Administration at an estimated cost of Rs. 150.00 lakhs (Rupees one hundred and fifty lakhs only) and 125.00 lakhs (one hundred and twenty five lakhs only) respectively. The Director of Municipal Administration has therefore requested the Government to allot Rs.275.00 lakhs (Rupees two hundred and Seventy five lakhs only) for this purpose under Part-II Scheme for the year 2010-11.

2. The Government after careful examination have decided to accept the proposal of Director of Municipal Administration in para 1 above, i.e for construction of office buildings for the Regional Directorates at Tiruppur and Salem at an estimated cost of Rs.150.00 lakhs (Rupees one hundred and fifty lakhs only) and 125.00 lakhs (one hundred and twenty five lakhs only) respectively under part II Scheme for the year 2010-11 and issues orders accordingly.

3. The amount sanctioned in para 2 above shall be debited to the following head of account:

“4217 Capital outlay on Urban Development - 60. Other Urban Development Schemes-051. Construction – Schemes in the Eleventh Five Year Plan-II State Plan –JG - Construction of Office Buildings – Municipal Administration.16.Major Works. (DPC 4217-60-051-JG-1608)”

3.The Director of Municipal Administration is authorized to draw the amount sanctioned in para 2 above and disburse it to both the Regional Directorates of Municipal Administration at Tirupur and Salem. The Director of Municipal Administration is requested to ensure that the new office buildings should be constructed within the financial year 2010-2011 and he is also directed to send the Completion report to the Government.
