**ORDER :**

In the Government Order first read above, the Tamil Nadu Water Supply and Drainage Board was permitted to approach HUDCO for a loan assistance of Rs.500 crores towards the execution of Urban Water Supply and Drainage Schemes. In the Government Order second read above, the Government have furnished guarantee for the repayment of the loan amount of Rs.500 crores to be availed of from the HUDCO. In pursuance of the Government orders, the Tamil Nadu Water Supply and Drainage Board has drawn the loan amount of Rs.20188.64 lakhs from the HUDCO, out of which, the Board after obtaining funds from the Government has repaid a sum of Rs.5583.35 lakhs upto the quarter ending on 30.06.2004. There was a balance loan amount of Rs.14605.29 lakhs to be repaid to HUDCO. The rate of interest for the capital loan with effect from 01.07.2004 was 10.75% p.a.

2. In the G.O. third read above, the Government have permitted Tamil Nadu Water Supply and Drainage Board to avail borrowings from the TUFIDCO at the rate of interest of 8.20% per annum to repay the entire outstanding loan with the HUDCO. Accordingly the TWAD Board has availed of loan assistance from the TUFIDCO and prepaid the entire outstanding loan amount of Rs.14605.29 lakh with the HUDCO as on 1.7.2004, for the loan drawn by the Tamil Nadu Water Supply and Drainage Board from the HUDCO towards the execution of Urban Water Supply and Drainage Schemes under packages I, II, III and IV indicated in the annexure II to this order. The rate of interest on the TUFIDCO loan is at 8.20% per annum. Out of the above said loan amount availed of from the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, a sum of Rs.8436.17 lakhs was repaid to the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited upto the quarter ended 31.03.2010. Thus the balance outstanding loan amount that remains to be repaid to the TUFIDCO as on 01.04.2010 is Rs.6169.12 lakhs.

3. The total amount required towards repayment of principal and payment of interest for the quarter ending 30.06.2010 to the TUFIDCO in respect of the Urban Water Supply Schemes is as follows:

4. The Chairman and Managing Director, TWAD Board has therefore requested to sanction and release a sum of Rs.4,93,25,696/- (Rupees four crores ninety three lakhs twenty five thousands six hundred and ninety six only) to TWAD Board for making payment to TUFIDCO towards repayment of Principal and Payment of Interest.

5. The Government, after careful examination, accord sanction for the release loan of Rs. 4,93,25,696/- (Rupees Four crores ninety three lakhs twenty five thousand six hundred and ninety six only) to the Tamil Nadu Water Supply and Drainage Board as loan towards repayment of principal and payment of interest for the quarter ending 30.06.2010 to the TUFIDCO as indicated in the Annexure I and Annexure II to this order.

6. The expenditure sanctioned in para 5 above, shall be debited to the following Head of account

"6215 – Loans for Water Supply and Sanitation –01. Water Supply – 190. Loans to Public Sector and other Undertakings – I. Non Plan – AG. Loans to Tamil Nadu Water Supply and Drainage Board for TUFIDCO Urban Water Supply – 01 Repayment of Principal and Interest to TUFIDCO for Urban Water Supply Schemes (DPC 6215-01-190-AG 0103) (outgo)"

7. The amount sanctioned in para 5 above shall not be paid in cash but it shall be credited to the head of account "K Deposits and Advances (b) Deposits not bearing interest – 8443.00 Civil Deposits – 800 other Receipts – BC - Deposits of Tamil Nadu Water Supply and Drainage Board (TWAD Board) DPC 8443.00.800.BC.000C Receipts)" by means of cheque drawn in favour of "Personal Deposit accounts of Managing Director, Tamil Nadu Water Supply and Drainage Board Account No.6184513396" as per G.O. Rt. No.1251 Finance (W&M II) Department, dated 30.12.2005.

8. The Section Officer (Bills), Municipal Administration and Water Supply Department is authorized to draw and disburse the amount sanctioned in para 5 above, through Pay and Accounts Office (Secretariat), Chennai –9 by means of Cheque as indicated in para 7 above.

9. The Chairman and Managing Director, Tamil Nadu Water Supply and Drainage Board shall ensure that the claim made by the TUFIDCO is in order and that there is no excess claim and no over payment made to TUFIDCO by the Tamil Nadu Water Supply and Drainage Board.

10. The Director of Municipal Administration is requested to raise necessary Demands against the Local Bodies concerned .The Chairman and Managing Director, Tamil Nadu Water Supply and Drainage Board shall surrender the balance amount if no expenditure out of the balance is likely to be incurred before the end of the financial year.
