ORDER:

In the Government order first read above, the Government have accorded administrative sanction for implementation of this scheme for improvement of basic structure in Town Panchayats by construction of 85 Pay and Use Sanitary Complex in 52 Town Panchayats at a total cost of Rs.536.45 lakhs (Rupees five hundred thirty six lakhs and forty five thousand only) with the loan assistance of Rs.456.18 lakhs from NABARD under RIDF-XV and State Government contribution of Rs.80.27 lakhs.

2. The Director of Town Panchayats in his letter second read above has stated that in Budget Estimate for 2010-11, a sum of Rs.2.00 crores has been provided to construct 85 pay and use sanitary complex in 52 Town Panchayats with assistance from NABARD - RIDF XV scheme and requested to sanction a sum of Rs.2.00 crore (Rupees Two crore only) for Construction of 85 Pay and Use Sanitary Complex in 52 Town Panchayats with assistance from NABARD-RIDF XV Scheme.

3. The Government after careful examination, decided to accept the proposal of the Director of Town Panchayats, in para 2 above and accordingly sanction a sum of Rs.2.00 crore (Rupees two crore only) for construction of 85 Pay and Use Sanitary Complex in 52 Town Panchayats with assistance from NABARD RIDF XV Scheme.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

“4515 00 - Capital Outlay on other Rural Development Programmes - 800 Other Expenditure - II State Plan - JU Construction of Pay and Use Sanitary Complex in Town Panchayats with loan assistance of NABARD –16 Major Works” (D.P.Code 4515 00 800 JU 1602).

5. The Director of Town Panchayats is authorised to draw the amount sanctioned in para 3 above and disburse to 52 Town Panchayats for construction of 85 Pay and Use Sanitary Complex by following the instructions in Government order first read above.
