Sub: Coimbatore City Municipal Corporation – Dedicated Water Supply Scheme to Coimbatore Corporation (Pillur II Scheme) under JNNURM Scheme – Detailed Project Report prepared by TNEB at an cost of Rs.12.07 crores and establishment cost of Rs.1.73 crores – Entrustment of work of Package 1 to TNEB – Permission sought from Government for an additional expenditure of Rs.4.50 crores for cost of pumps from Corporation Funds – Estimated cost Rs.13.80 crores for entrusted to TNEB as deposit work and execution through TNEB – Forwarded to Government to accord Administrative sanction – Reg.

I am directed to invite attention to the references cited.

2. In G.O.(D)No.160, Municipal Administration and Water Supply Department, dated 17.4.2007, the Government have accorded administrative sanction for the five projects under JNNURM at a total cost of Rs.352.73 crores. Dedicated water supply scheme to Coimbatore Corporation-Pillur phase II at a cost of Rs.113.74 crores is one among them. As per the DPR the work of construction of Collection Well-cum-Pump House at the bank of the Dam with provision for suitable intake arrangements is, Package-I of the above said project.

3. In the reference second cited the Commissioner of Municipal Administration has sought for the orders on the following:-

- a. to entrust the civil work of Package-I to the TNEB at an estimated cost of Rs.12.07 crores with establishment cost of Rs.1.73 crores totaling to Rs.13.80 crores as deposit work;
- b. to incur additional expenditure of Rs.4.50 crores by the Coimbatore Corporation towards the cost of motor pump sets as furnished by the TNEB.

4. The Government after careful consideration accords permission for entrusting the civil work of Package -I at an estimate cost of Rs.12.07 crores with establishment cost of Rs.1.73 crores totaling to Rs.13.80 crores, to TNEB as deposit work.

5. Regarding the incurring of additional expenditure of Rs.4.50 crores by the Coimbatore Corporation, towards the cost of motor pump sets, as furnished by the TNEB, it is considered that no Government orders are required in view of the fact that the cost will be within 10% of the permissible limit over and above the administrative sanction.
