



### ABSTRACT

Establishment - Tamil Nadu Municipal Commissioners' Subordinate Service - Tvl. V. Chakrapani, and V.P. Thandapani, Municipal Commissioners - Elevation to the cadre of Joint Director of Municipal Administration - Consequent transfers and postings - Orders - issued.

### ORDER:-

The Commissioner of Municipal Administration in his letter read above has reported that 3 posts in the cadre of Joint Director of Municipal Administration are now vacant and these posts are to be filled up from among the Municipal Commissioners holding charge of Special Grade Municipalities and consequently, they become eligible to be posted in any of the Joint Director vacancies on a working arrangement basis. Since regular panels are not available for promotion to the post of Joint Director and Municipal Commissioner Special Grade, Selection Grade and First Grade, the vacancies in Joint Director cadre, Special Grade, Selection Grade and First Grade have been filled up by posting persons from lower grades as per seniority on a working arrangement basis without any monetary benefit with the preferential claims as per the seniority issued vide G.O.(4D)No.4, Municipal Administration and Water Supply Department, dated 26.08.1997.

2. The Commissioner of Municipal Administration has further stated that Thiru. C.T. Duravelan, Municipal Commissioner, Pottachi in his letter dated 17.10.2006 has informed that he is a chronic diabetic and his health would not permit him to have frequent tours and has relinquished his elevation. The Commissioner of Municipal Administration has also stated that a disciplinary case under Rule 17(b) of Tamil Nadu Civil Services (Discipline and Appeal) Rules initiated against Thiru. C.T. Duravelan is still pending and hence, his name was not recommended for elevation to the post of Joint Director of Municipal Administration.

3. The Commissioner of Municipal Administration has, therefore, proposed that Tvl. V. Chakrapani and V.P. Thandapani, Municipal Commissioners now working in Special Grade Municipality may be elevated to the cadre of Joint Director of Municipal Administration and consequently suggested the following transfers and postings:-

- (i) Thiru V. Chakrapani, Municipal Commissioner, Ambattur may continue as Municipal Commissioner in the same station in the cadre of Joint Director of Municipal Administration in view of the sensitive nature of the local body and the enormous work-load there.
- (ii) Thiru V.P. Thandapani, Municipal Commissioner, Kumbakonam may be transferred and posted as Regional Director of Municipal Administration, Thanjavur in the cadre of Joint Director of Municipal Administration vice Thiru S.K. Anwar Basha, Regional Director of Municipal Administration, Thanjavur and he may be placed in full additional charge of the post of Municipal Commissioner, Kumbakonam taking into consideration on the importance of the ongoing development works in the local body.
- (iii) Thiru S.K. Anwar Basha, Regional Director of Municipal Administration, Thanjavur may be transferred and posted as Regional Director of Municipal Administration, Salem in the existing vacancy.

4. The Government, after careful examination of the proposal of the Commissioner of Municipal Administration, accept the same and accordingly elevate Tvl. V. Chakrapani and V.P. Thandapani, now working in Special Grade Municipalities to the cadre of Joint Director of Municipal Administration. The individuals are not eligible for any preferential claim or seniority or pay fixation etc., They will continue to draw the pay in the time scale of pay now being drawn by them.

5. The Government also accept the proposal of the Commissioner of Municipal Administration and order the following transfers and postings:-

- i) Thiru V. Chakrapani, Municipal Commissioner, Ambattur on elevation to the cadre of Joint Director of Municipal Administration will continue as Municipal Commissioner in the same station in the cadre of Joint Director of Municipal Administration in view of the sensitive nature of the local body and the enormous work-load there.
- ii) Thiru V.P. Thandapani, Municipal Commissioner, Kumbakonam on elevation to the cadre of Joint Director of Municipal Administration is transferred and posted as Regional Director of Municipal Administration, Thanjavur in the cadre of Joint Director of Municipal Administration vice Thiru S.K. Anwar Basha, Regional Director of Municipal Administration, Thanjavur. Thiru. V.P. Thandapani is also placed in full additional charge of the post of Municipal Commissioner, Kumbakonam taking into consideration the importance of the ongoing development works in the local body.
- iii) Thiru S.K. Anwar Basha, Regional Director of Municipal Administration, Thanjavur is transferred and posted as Regional Director of Municipal Administration, Salem in the existing vacancy.



6. The Commissioner of Municipal Administration is requested to ensure that the above transfer and postings are given effect to, immediately.
