Grant – State Finance Commission Devolution Grant to Municipalities and Municipal Corporations for the year 2007-08 – Release of Funds for the months of February and March 2008 - Orders – Issued.

ORDER:

In G.O.(D) No.289, Municipal Administration and Water Supply (MA.II) Department, dated 27.6.2007 orders were issued for sanction and release of State Finance Commission Devolution to the Urban Local Bodies in 10 instalments on monthly basis from April 2007 to January, 2008 as follows:

For the months from April 2007 to January, 2008.

Municipalities	- Rs.32,00,45,500/- p.m. (Rupees Thirty two crores forty five thousand and five hundred only.)
Municipal Corporation	- Rs.23,41,79,643/-p.m. (Rupees Twenty three crores forty one lakhs seventy nine thousand and six hundred and forty three only.)

2. Now the Commissioner of Municipal Administration in his letter third above has requested to release the remaining 4 instalments based on the R.E. for the months of February, 2008 and March, 2008.

3. The Third State Finance Commission Grant for the remaining 4 instalments is worked out as follows:-

1. Municipalities - Rs.32,00,45,500 x 4 = Rs.128,01,82,000/-
2. Municipal Corporations - Rs.23,41,79,643 x 4 = Rs. 93,67,18,572/-

The above amount has to be released for the months of February, 2008 and March 2008 which is worked out as follows:-

Municipalities - February 2008 & March 2008
128,01,82,000 = 64,00,91,000/-

Municipal Corporations - February 2008 & March 2008
93,67,18,572 = 46,83,59,285/-

5. Sanction is accorded for the release of State Finance Commission Devolution grant of Rs.221,69,00,570/- (Rupees Two hundred and twenty one crore sixty nine lakhs and five hundred and seventy only) for the month of February, 2008 and March, 2008 as follows:-

6. The Commissioner of Municipal Administration is authorized to draw and disburse the amount sanctioned above to Municipalities / Municipal Corporations respectively. The amount so drawn shall be distributed to the Urban Local Bodies on the basis of 2001 Census population.

7. The Commissioner of Municipal Administration is authorized and permitted to present bill and draw the amount in periodical instalment.

8. The Commissioner of Municipal Administration is authorized to effect recoveries of loans or other charges as per schedule from the State Finance Commission Devolution.

9. As per the G.O. third read above, the Commissioner of Municipal Administration is also requested to pursue necessary action to distribute 10% of the devolution share of Chennai Corporation to Chennai Metropolitan Water Supply and Sewerage Board.

10. The Pension commitment of local body pensioners shall be deducted from the devolution amount for the respective local bodies instead of respective tiers.

11. The amount sanctioned in para 5 above shall be debited to the following heads of accounts:

Municipalities: Rs.128,01,82,000/-

3604 - 00 - Compensation and assignments to Local Bodies and Panchayat Raj Institutions - 192 - Assistance to Municipalities, Municipal Councils - I-Non-Plan - AA. Municipal Corporations: Rs.93,67,18,570/-
