ORDER:

The Commissioner of Municipal Administration in his letter read above has stated that the working environment plays a vital role in discharging services to the public. Since e-governance is being implemented in all the Urban Local Bodies, it requires modern facilities to accommodate computers and its peripherals. Certain Urban Local Bodies have reported that they do not have sufficient Office buildings to accommodate different branches like General, Public Health, Town Planning, Engineering, and Computer Wing. Hence in the year 2007-08, it is proposed to construct / upgrade Office buildings for the following Urban Local Bodies at the total cost of Rs.300.00 lakhs. As the financial position of these Urban Local Bodies are not sound, the Commissioner of Municipal Administration has requested that this scheme may be included under Part II Scheme for the year 2008-09 and an amount of Rs.300.00 lakhs may be allocated in Budget for 2008-09 for the construction / upgradation of Office Buildings to the following 10 Municipalities.

- 2. The Government after careful examination, accept the proposal of the Commissioner of Municipal Administration in para 1 above and sanction a sum of Rs.300.00 lakhs (Rupees three hundred lakhs only) for Construction / Upgradation of office Buildings in the above10 Municipalities under Part II Scheme for the year 2008-2009, as approved by the Standing Finance Committee.
- 3. The amount sanctioned in para 3 above shall be debited to the following head of account:-
- "2217 Urban Development 05. Other Urban Development Schemes 192. Assistance to Municipalities / Municipal Councils II. State Plan JA. Assistance to Municipalities for Infrastructure development 09. Grants-in-Aid-02. Grants for Capital Expenditures (DPC 2217-05-192-JA-0926)
- 4. The Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 3 above and disburse it to all the 10 Municipalities in 3 instalments. 15% of the amount may be drawn and paid to the respective local bodies as start up advance. The balance amount may be drawn in 2 equal instalments, first instalment on approval of the scheme and DPR by the council and the second instalment released on completion of 75% work. The Commissioner of Municipal Administration is requested to ensure that the new office buildings should be constructed or the existing buildings upgraded within

the financial year 2008-2009 and he is also requested to send the progress reports then and there.
