Municipal Administration And Water Supply Department – Part II Schemes 2008-2009 – Conversion of Earthen Road into BT/CC Roads in ULBs – Sanction of Rs.1000.00 lakhs (Rupees One Thousand lakhs only) as grant – Orders – Issued.

The Hon'ble Minister for Rural Development and Local Administration had announced on the floor of Assembly that the narrow earthen lane and wide earthen Road of 2000 kms in Municipalities and Municipal Corporations will be converted as B.T/CC Roads respectively in the next four years.

2) The Commissioner of Municipal Administration has sent a proposal for conversion of earthen Roads in to B.T/CC Roads in Urban Local Bodies for an amount of Rs.1000.00 lakhs under Part –II Scheme for the year 2008 – 2009. The standing Finance Committee has approved the scheme.

3) The Government, after careful examination, accept the proposal and sanction a sum of Rs.1000.00 (Rupees one thousand lakhs only) as one time grant for the conversion of 62.60 kms earthen Roads in to B.T/CC Roads in Urban Local Bodies as mentioned in the annexure to this order.

4) The amount sanctioned in para 3 above shall be debited to the following head of account: -

2217. Urban Development – 05. Other Urban Development Schemes – 191. Assistance to Municipal Corporations – II. State Plan – JX. Conversion of Earthen Roads in Municipal Corporations into black topped roads – 09. Grants – in – Aid – 02. Grants for Capital expenditure (DPC 2217 05 191 JX 0922) – Rs.180.00 lakhs - 2217. Urban Development – 05. Other Urban Development Schemes – 192. Assistance to Municipalities / Municipal Councils – II State Plan – JG. Conversion of Earthen Roads in Municipalities into black topped roads – 09. Grants – in – Aid – 02 – Grants for capital expenditure (DPC 2217 05 192 JG 0924) – Rs.820.00 lakhs.

5) The Commissioner of Municipal Administration, is authorised to draw and release the amount sanctioned in para 3 above in 3 instalments, i.e. 15% as start up advance may be released now. The balance 85% may be released in 2nd and 3rd instalments (i.e.) 35% based on the project approval by the Municipalities/Municipal Corporations and 50% on completion of works respectively. The Commissioner of Municipal Administration is also requested to send the progress report to Government.
