Order:

The Commissioner of Municipal Administration in his letter read above has stated that the remote controlling of valves monitoring through computers is the latest technique adopted quite recently in major water supply schemes. It is known as Supervisory Control and Data Acquisition system . He has proposed to take up this in Tirunelveli Corporation in the first instance. This will make easy, the operation of valves and proper monitoring. The estimated cost for this project is Rs.0.63 crores.

2. The Government after careful examination accept the proposal and accord administrative sanction for a sum of Rs.63.00 lakhs (Rupees Sixty Three lakhs only) as one time grant to provide Supervisory Control and Data Acquisition system in Tirunelveli Corporation under Part II Scheme for the year 2008-2009.

3) The amount sanctioned in para 2 above shall be debited to the following Head of Accounts:-

"2217.Urban Development -01. State Capital Development -191. Assistance to Municipal Corporations - II - State Plan - JT Assistance to Corporations for SCADA(Supervisory Control and Data Acquisition) System - 09 → Grants-in-Aid - 03 . Grants for Specific Schemes (DPC 2217 - 01 - 191 - JT -0933)"

4) The Commissioner of Municipal Administration is authorised to draw the amount sanctioned in para 2 above and disburse it to the Tirunelveli Corporation in 3 instalments. 15% of the amount may be drawn and paid to Tirunelveli Corporation as start up advance. The balance amount may be drawn in 2 equal instalments, first instalment on approval of the scheme and second instalment on progress of work. The Commissioner of Municipal Administration is also requested to send the progress report to Government.
