Order:

The Commissioner of Municipal Administration in his letter read above has stated that the Tamil Nadu Institute of Urban Studies is an urban training institute situated at Coimbatore. It is functioning since 1981. At present it caters to the training needs of all Municipal Corporations, Engineers and other officials besides the staff. The Institute has hostel accommodation for 50 trainees and also a dormitory for 20 trainees. He has also stated that there is a need to modernize the hostel to bring in a pleasing learning atmosphere for the trainees by reconstructing the hostel after due remodeling. The construction of Ground Floor is estimated at a cost of Rs.1.50 crores.

- 2. The Government after careful examination accept the proposal and accord administrative sanction for a sum of Rs.150 lakhs (Rupees One Hundred and fifty lakhs only) as grant to modernize the hostel by reconstructing the Ground Floor of Hostel in Tamil Nadu Institute of Urban Studies, Coimbatore under Part II Scheme for the year 2008-2009.
- The amount sanctioned in para 2 above shall be debited to the following Head of Accounts;-

"2217.Urban Development -05. Other Urban Development Schemes -192. Assistance to Municipalities /Municipal Councils -II- State plan -JH Assistance to Municipalities for training -09 - Grants - in - aid - 03. Grants for Specific Schemes (DPC 2217 - 05 - 192 - JH -0931)"

- 4) The Commissioner of Municipal Administration is authorised to draw and release the amount sanctioned in para 2 above in 3 instalments. 15% of the amount may be drawn and paid to Tamil Nadu Institute of Urban Studies, Coimbatore as start up advance. The balance amount may be drawn in 2 equal instalments, first instalment on approval of the scheme and second instalment on progress of work. The Commissioner of Municipal Administration is also requested to send the progress report to Government.
