ORDER:

The Commissioner of Municipal Administration in his letter read above has stated that at present the leak detection in Water supply network and the conveying main is being done departmentally by engaging plumbers manually which takes time and invites the complaints from the public. He has proposed to provide a system of attending such leaks through providing a mobile water leak detection device and repairing vans in 7 Municipal Corporations and 10 special Grade Municipalities as mentioned in the Annexure to this order. It will be equipped with staff, materials, cell phone and wireless sets to attend leaks then and there. The approximate cost of such 17 vans will be around Rs.1.70 crores.

2. The Government after careful examination accept the proposal and accord administrative sanction for a sum of Rs.170 lakhs (Rupees One Hundred and Seventy lakhs only) as one time grant for purchase of Mobile Water leak detection and repairing vans (Blue brigade) in 7 Municipal Corporations and 10 Special grade Municipalities as mentioned in the annexure to this order, under part II scheme for the year 2008-2009.
