ORDER:

The Commissioner of Municipal Administration, in his letter first read above has stated that there are many Channels / Ponds under the control of Urban Local Bodies and many Channels are under the maintenance of Public Works Department. In order to improve the environment by cleaning of such water bodies, the provision of cement concrete lining is necessary. He has therefore requested the Government to sanction an amount of Rs.150.00 lakhs under Part -II Scheme for 2008-2009 to the 11 Urban Local Bodies mentioned in the Annexure. The State Planning Commission and the Standing Finance Committee have approved the proposal.

2. The — Government, after careful examination, accept the proposal of the Commissioner of Municipal Administration for the Improvement of Water bodies. Channels / Ponds in 11 Urban Local Bodies under Part II Scheme for 2008 - 2009 as in the Annexure to this order and sanction an amount of Rs.150.00 lakhs ( Rupees One hundred and fifty lakhs only) as one time grant.

4. The Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 2 above and disburse it to all the 11 Urban Local Bodies listed in the Annexure. The Municipalities may send the Work Progress Report to the Commissioner of Municipal Administration and the Commissioner of Municipal Administration may be requested to send the work Completion Report to Government.
