## ORDER:

In the G.O. first and second read above, the Government have released an amount of Rs.82,29,74,000/- to the Urban Local Bodies in Tamil Nadu as XII Finance Commission Grant for the year 2007-08. In the Budget estimate for the year 2008-09 the Government have provided funds towards Twelfth Finance Commission grants as follows:-

 The Commissioner of Municipal Administration has therefore requested the Government to release the first instalment grant as per the Budget Estimate 2008-2009. 3. The Government after careful consideration sanction and release the 1st instalment grant for 2008-09 in anticipation of its receipt from Government of India as follows:

- 4. The distribution among various municipalities shall be made by way of giving 75% weightage to population (2001 census) and 25% weightage to financial parameters.
  - 5. The amount sanctioned in para 3 above shall be utilized as below:-
  - (a) 50% for the scheme of Solid Waste Management through Public Private Partnership. The Municipalities should concentrate on Collection, Segregation and transportation of Solid Waste. The cost of these activities whether carried out in house or out-sourced could be met from the grants.
  - (b) 25% of the grant for conversion of earthern / metal road into BT/CC road and for the formation of storm water drains wherever required.
  - (c) 25% for miscellaneous works such as creation of data base payment of electricity charges etc.
- 6. The Commissioner of Municipal Administration is requested to ensure that the 50% of the grants sanctioned in para 3 above are utilized only for the schemes of Solid Waste Management and the balance 50% shall be utilized for the purposes as mentioned in para 5(b) and (c) above.
- 7. Necessary provisions have been made in the B.E. 2008-2009. The Commissioner of Municipal Administration is authorized to draw and disburse the amount sanctioned in para 3 above to all Municipal Corporations / Municipalities / IIIrd Grade Municipalities.
- 8. The Commissioner of Municipal Administration is also requested to send the Utilisation Certificates for the utilization of the amount sanctioned in para 3 above to the Government in the format prescribed by Government of India so as

to forward the same to the Government of India and to get the release of the second instalment by Government of India.

The expenditure sanctioned in para 3 above shall be debited to the following head of account.
