



**ABSTRACT**

**ORDER:-**

In the G.O. first read above, the Government have accorded administrative sanction of Rs.1425.08 lakh for providing amenities to 20 habitations in 5 Urban Local Bodies of Vedharaniyam, Nagapattinam, Colachel, Kayalpattinam and Cuddalore.

2. In the G.O. second read above, the Government have released Rs.200.00 lakhs (Rupees Two crores only) in the year 2006-2007 to the 5 Tsunami affected Urban Local Bodies of Vedharaniyam, Nagapattinam, Colachel, Kayalpattinam and Cuddalore.

3. In the G.O. third read above, the Government have released the balance amount of Rs.12,25,08,000/- (Rupees Twelve crores twenty five lakhs and eight thousand only) for providing basic amenities in five Urban Local Bodies of Vedharaniyam, Nagapattinam, Colachel, Kayalpattinam and Cuddalore.

4. The Commissioner of Municipal Administration has stated that out of 30 packages taken up under Emergency Tsunami Reconstruction Project (ETRP), tenders were received below the estimated value for 2 packages, 4 packages were taken as Departmental works and for 24 packages, tenders were finalized above the estimated value due to the price escalation. The Revised Administrative sanction is now required for the 30 packages which works out to Rs.16,37,86,670/- as against the administrative sanction of Rs.14,25,08,000/- as detailed below:-

5. The Officer on Special Duty (Relief and Rehabilitation) has placed the above proposal before the Empowered Committee meeting held on 15.7.2008. The Empowered Committee has approved the proposal.

6. The Government after careful consideration accept the proposal of the Commissioner of Municipal Administration as recommended by the Empowered Committee to accord Revised Administrative Sanction for the 30 packages taken up under Emergency Tsunami Reconstruction Project (ETRP) for a sum of **Rs.16,37,86,670/- (Rupees Sixteen crores thirty seven lakhs eighty six hundred and seventy only)** as against the administrative sanction of Rs.14,25,08,000/- and accord sanction for an additional amount of **Rs.2,12,78,670/- (Rupees Two crores twelve lakhs seventy eight thousand six hundred and seventy only)** towards the additional cost of works under Roads and Drains and Street Lights components.

7. The expenditure sanctioned in paragraph 6 above shall be debited to the following head of account:-

**"4217 - Capital Outlay on Urban Development-60. Other Urban Development Schemes-051. Construction Scheme in the Eleventh Five Year Plan-II. State Plan-QA. Provision of basic amenities to new habitations under Emergency Tsunami Reconstruction Project (ETRP)-16. Major works."

8. Necessary funds will be provided in RE/FMA 2008-2009. Pending provision of such funds, the Commissioner of Municipal Administration is authorized to draw and disburse the amount, sanctioned in paragraph 4 above, as per the existing procedure and send the statement of expenditure, Utilization Certificate, the progress report as laid down by World Bank in consultation with Project Director to Government and Accountant General. He is also requested to send necessary proposals for RE/FMA 2007-2008 at an appropriate time.
