**ORDER:**

In the G.O. read above, orders were issued directing the Tamil Nadu Water Supply and Drainage Board to adopt the existing rate of 13% of Centage Charges for Minimum Needs Programme works and at varying rates in respect of Government of India Schemes as allowed by them for the year 2004-2005.

In the letter second read above, the Managing Director, Tamil Nadu Water Supply and Drainage Board has requested the Government to permit the Tamil Nadu Water Supply and Drainage Board to fix the centage charges for the year 2005-2006 and 2006-2007 at 18% from the prevalent rate of 13% on the works executed by the Tamil Nadu Water Supply and Drainage Board under Minimum Needs Programme.

3. The Government after careful consideration, direct the Tamil Nadu Water Supply and Drainage Board to adopt the existing rate of 13% of Centage Charges for

Minimum Needs Programme works and at varying rates in respect of Government of India Schemes as allowed by them for the years 2005-2006 and 2006-2007.

4. The Managing Director, Tamil Nadu Water Supply and Drainage Board is requested to send suitable proposals with due justification for revision of Centage Charges for the year 2007-2008.
