Order :-

In the letter second read above, the Commissioner of Municipal Administration has stated that the project of Solid Waste Management in Madurai Corporation had been sanctioned by the Central Sanctioning and Monitoring Committee at an estimated cost of Rs.74.26 crores. The project components have been divided into seven packages, of which Packages 1 to VI are for the procurement of machineries for primary and secondary collection, and Package VII is for waste processing and the establishment of a sanitary landfill facility. Necessary proposals were invited under National Competitive Bidding for Packages 1 to VI and for Package VII, proposals were invited under the Public Private Participation (PPP) mode.

2) He has also stated that the "Requests for Qualification" (RFQ) were called for from eligible firms. During the second call, bids were received from ten firms. The Evaluation Committee constituted by the Madurai Corporation recommended five firms as responsive in the technical evaluation stage. The "Request for Proposals" had been called for from among the five firms selected. Upon evaluation of their technical proposals, the Evaluation Committee recommended two of these firms as qualified for opening of their financial proposals. Of the two, M/s Subhash Projects and Marketing Limited (SPML) had given the lowest NPV value. The work has been awarded to M/s SPML under Public Private Participation mode. A private limited company was registered in the name of "The Madurai Municipal Waste Processing Company Private Limited" under the Companies Act 1956 on 8.3.2008.
