ORDER:-

Under Rule 2 of the Special Rules for Tamil Nadu Municipal Commissioners' Subordinate Service, the following 11 candidates selected by the Tamil Nadu Public Service Commission from Open Market are appointed as Municipal Commissioner, Grade-II in the Tamil Nadu Municipal Commissioners' Subordinate Service -

- 2. The appointment as Municipal Commissioner, Grade-II is purely provisional subject to the final outcome of the W.P.No.37785/07, W.P.No.562/08 and other O.As / W.Ps. relating to this recruitment pending on the files of Hon'ble High Court, Madras / Madurai Bench of Hon'ble High Court of Madras.
- 3 The Commissioner of Municipal Administration is requested to obtain the physical fitness certificates of the directly recruited candidates appointed in paragraph 1 above and file them in his office. Their appointment made in paragraph 1 above is subject to production of physical fitness certificates to the Commissioner of Municipal Administration, Chennai and that they being found medically fit by the Commissioner of Municipal Administration. In respect of physically handicapped candidates the Commissioner of Municipal Administration is requested to verify their Percentage of handicap and capacity to perform their duty through the District Medical Board.
- The orders fixing the inter-se-seniority of the above persons will be issued separately.
- Under Section 12 (c)of the Tamil Nadu District Municipalities Act.
 1920 (Tamil Nadu Act v of 1920), the Governor of Tamil Nadu hereby makes the following appointments and postings -
- (1) Tmt. G. Dhanalakshmi is appointed as Municipal Commissioner, Grade-II and posted in Kulithalai Municipality.
- (2) Thiru. P. Ashok Kumar is appointed as Municipal Commissioner, Grade-II and posted in Shenkottai Municipality.
- (3) S Sasikala is appointed as Municipal Commissioner, Grade II and posted in Vandavasi Municipality
- (4) K. Uma Maheswari is appointed as Municipal Commissioner, Grade-II and posted in Aranthangi Municipality
- (5) Thiru. P.M.N. Mujibeer Rahumaan is appointed as Municipal Commissioner. Grade-II and posted in Thirumangalam Municipality.

- (6) Thiru K. Saravanan is appointed as Municipal Commissioner, Grade-II and posted in Koothanallur Municipality
- (7) Thiru C Muthukumaran is appointed as Municipal Commissioner. Grade-II and posted in Nellikuppam Municipality
- (8) K. Achaiya is appointed as Municipal Commissioner, Grade-II and posted in Usilampatti Municipality
- (9) Tmt. M. Shanthi is appointed as Municipal Commissioner, Grade-II and posted in Melur Municipality.
- (10) S. Parijatham is appointed as Municipal Commissioner, Grade-II and posted in Wallajapet Municipality.
- (11) Thiru. K. Saravanakumar is appointed as Municipal Commissioner, Grade-II and posted in Periyakulam Municipality.
- 6. The Commissioner of Municipal Administration is instructed to send the individuals on appointment as Municipal Commissioner, Grade-II to undergo training as stipulated under Rule 8 of Special Rules for Tamil Nadu Municipal Commissioners' Service. The Commissioner of Municipal Administration is requested to ascertain from them whether they have registered their names with any Employment Exchange. If so they may be asked to surrender Employment Exchange Identity Card and it may be sent either to the Employment Exchange where such candidates have registered their names or to the Director of Employment and Training so that the registration of the concerned candidates may be removed from the Live Register of the Employment Exchange.
- 7. The 11 Direct Recruitment candidates appointed as Municipal Commissioner, Grade-II in para 1 above are informed that they should produce the certificates of physical fitness to the Commissioner of Municipal Administration and join duty at the respective places of their training within one month from the date of receipt of this order and that no kind of representation will be entertained on this account and that failure to join duty within the specified time limit and at the specified place will result in their names being removed from the approved list.
- 8. The Government also direct that till the completion of the training, the existing additional charge arrangements in the Municipalities in which the above 11 candidates (open market candidates) are to be posted may continue and they may join the Municipalities immediately after completion of their training.

9 The pay and allowances and contribution towards leave salary. Provident Fund and Pension of the above Commissioners will be met from the funds of the respective Municipal Councils to which they are posted, in accordance with the orders in force. The conveyance allowance to the Municipal Commissioners will be regulated as per the orders in force.
