ORDER:

In the G.O. read, above the Government have released an amount of Rs. 41,1487 crore to the ULBs in Tamil Nadu as XII Central Finance Commission Grants as Ist Installment

 The Director of Municipal Administration in his letter read above has stated that in the Budget Estimate for the year 2009 – 2010, the Government have provided funds

towards Twelfth Finance Commission grants as follows:

1	Grants to Municipal Corporations as per the recommendation 12 th Finance Commission – controlled by	Rs. 35,46,40,000/-
2	Grants to Municipalities as per the recommendation of 12 th Finance Commission – controlled by DMA	Rs. 38,89,60,000/-
3	Grants to Third Grade Municipalities as per the recommendation of 12 th Finance Commission – Controlled by DMA.	Rs. 7,93,74,000/-
	Total	Rs. 82,29,74,000/-

The Director of Municipal Administration has therefore requested the Government to release the balance 50% of the amount as lind installment grant as per the Budget Estimate for the year 2009 -2010 so as to distribute the funds to the ULBS.

 The Government after careful examination and in anticipation of the receipt of second installment from Government of India sanction and release the second Installment grant for the year 2009 – 2010 as follows:-

- 4. The distribution among various municipalities shall be made by giving 75% weightage to population (2001 census) and balance 25% weightage to financial parameters.
 - 5. The amount sanctioned in para 3 above shall be utilized as below:-
 - (a) 50% for the scheme of Solid Waste Management through Public Private Partnership. The Municipalities should concentrate on collection, segregation and transportation of Solid Wastes. The cost of these activities whether carried out inhouse or out-sourced could be met from the grants.
 - (b) 25% of the grant for conversion of earthen/metal road into BT/CC roads and for formation of storm water drains wherever required.
 - (c) 25% for miscellaneous works such as creation of database, payment of electricity charges etc.
- 6. The Director of Municipal Administration is directed to ensure that 50% of the grants sanctioned in para 3 above are utilized only for the schemes of Solid Waste Management and the balance 50% shall be utilized for the purposes as mentioned in para 5 (b) and (c) above.
- Necessary provisions have been made in the Budget Estimate 2009 2010.
 The Director of Municipal Administration is authorized to draw and disburse the amount sanctioned in para 3 above to all Municipal Corporations/Municipalities/Illrd Grade Municipalities.
- 8. The Director of Municipal Administration is also directed to furnish the Utilization Certificates for the utilization of the amount sanctioned in para 3 above to the Government in the format prescribed by Government of India so as to forward the same to the Government of India, early.
- 9 The expenditure sanctioned in para 3 above shall be debited to the following heads of account:-
