### AMENDMENTS.

(1) In the said Notification, in the preamble,

for the expression "and Section 8 of the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994)", the following expression shall be substituted,

namely:-

"Section 8 of the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994), Section 8 of the Tiruppur City Municipal Corporation Act, 2008 (Tamil Nadu Act 7 of 2008), Section 8 of the Erode City Municipal Corporation Act, 2008 (Tamil Nadu Act 8 of 2008), Section 8 of the Vellore City Municipal Corporation Act, 2008 (Tamil Nadu Act 26 of 2008) and Section 8 of the Thoothukudi City Municipal Corporation Act, 2008 (Tamil Nadu Act 27 of 2008)";

(a) (i) in clause (i), the word "and" occuring after the expression "the Tirunelveli City Municipal Corporation Act, 1994 (Tamil Nadu Act 28 of 1994) in respect of Tirunelveli City Municipal Corporation; "shall be omitted;

(ii) for the expression "the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994) in respect of the Salem City Municipal Corporation.",

the following expression shall be substituted, namely:-

"the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994) in respect of the Salem City Municipal Corporation;

"the Tiruppur City Municipal Corporation Act, 2008 (Tamil Nadu Act 7 of 2008) in respect of Tiruppur City Municipal Corporation; the Erode City Municipal Corporation Act, 2008 (Tamil Nadu Act 8 of 2008) in respect of Erode City Municipal Corporation; the Vellore City Municipal Corporation Act, 2008 (Tamil Nadu Act 26 of 2008) in respect of Vellore City Municipal Corporation; and the Thoothukudi City Municipal Corporation Act, 2008 (Tamil Nadu Act 27 of 2008) in respect of Thoothukudi City Municipal Corporation.";
