#### ORDER:

In the Government order 1<sup>st</sup> read above, orders were issued to implement the project by name Tamil Nadu Urban Road Infrastructure Project (TURIP) for improving the urban road infrastructure and to maintain the network of roads constructed under the project. The Urban Local Bodies selected will be provided with Pavements, Storm Water Drain and provision of Ducts for laying of utilities such as electrical cables, Water and Sewer lines etc., In the first phase Tamil Nadu Urban Road Infrastructure Project scheme is proposed to be implemented in the following Corporations and Municipalities.

In the Government order first read above it was also decided to appoint a Design Supervision, Management Consultant for preparation of Detailed Project Report including the designs and supervision and management of the implementation of the Tamil Nadu Urban Road Infrastructure Project. Accordingly a rough cost estimate for the appointment of Consultant Services for design, Supervision and Management for Developing Urban Road Infrastructure for the above 12 Urban Local Bodies were prepared by Tamil Nadu Urban Infrastructure Financial Services Limited, at a cost of Rs.32.50 crores (including cost of advertisement and other related expenses). The Empowered Committee constituted by Government in the Government order first read above has resolved to accord sanction and recommended the above proposal.
- 3. The Director of Municipal Administration in his letter second read above has requested to issue Administrative sanction for taking up the consultancy assignment to take up the work at an estimate cost of Rs.32.50 crores by Tamil Nadu Urban Infrastructure Financial Services Limited.
- 4. After careful examination, the Government have decided to accept the proposal of Director of Municipal Administration to accord administrative sanction for appointing Consultant for Design Supervision, Management (DSM) for developing Urban Road Infrastructure in 12 Urban Local Bodies at a rough cost of Rs.32.50crores and issue orders accordingly.
