Sub: Leave Travel Concession - Further clarifications - issued.

In the references cited some clarifications have been issued regarding sanction of Leave Travel Concession to Government Employees. Now the following further points are clarified as regard to sanction of Leave Travel Concession to Government Employees.

S.No. POINTS RAISED POINTS CLARIFIED

1. Whether a Government The Government Servants son

Servant's son worked temporarily and subsequently ousted from service can be considered as dependent of the Government Servant.

The Government Servants son who worked temperarily and subsequently ousted from service may be considered as dependent of the Government servant for the purpose of Leave Travel Concession, subject to the condition that on the date of application for Leave Travel Concession he remains unemployed.

2. Whether a Government servant who performed journey within the block year by proceeding on 15 days leave starting at the end of December 1982 and continued in January, 1983

In Govt.Lr.No.118982/All.I/ 82-1, dated 11.2.83, it has been clarified that the Govt. servant who takes leave for 30 days E.L.from 17.12.82 to 16.1.83, is eligible for two fares, that is one for onward

and the other for return

before the issue of orders in Government Lr.No.118982/ All.I/82-1, dt.11.2.83 is eligible for leave Travel Concession for the block year 1983-84.

journey as two blocks of uears are involved, ie. 1981-82 and 1983-84. It has also been clarified that the 15 days of E.L. should fall within that block year. As the clarification that the leave of 15 days E.L. should fall within that block year has been issued only on 11.2.83 a Government servant who performed journey within the block year by proceeding on 15 days leave starting at the end of December 82 and continued in January 1983 before the issue of orders in Govt.Lr.No.118982/ All.I/82-1, dated 11.2.83 is eligible for Leave Travel concession for the block year 1983-84.

- 3. Whether the dependent parents of Govt. Servants are also included as members of family of the Govt. Servants for purpose of claiming leave Travel concession.
- The term "Family" has to be defined as in Rule 2 (iv) of the Tamil Nadu Travelling Allowance Rules. As per the explanation 2 of the said rule, the parents residing with and wholly dependent on Govt. Servants have to be treated as family members. As such, the dependent parents of Govt. Servants are included asmembers of family of Govt. Servants for the purpose of Leave Travel Concession.
- 4. Whether a Govt. Servant whose destination falls outside Tamil Nadu is eligible for Leave Travel Concession subject to claiming the fare upto the Tamil Nadu Territory.
- Necessary clarification in this regard has already been issued in govt.Lr. No.118982/All.I/82-1, dt. 11.2.83.
- 5. Whether the spouse of the Govt. Employee of Railways, Pallavan Transport and Similar organisations is eligible for leave travel concession since the organisations are issuing passes every year to enable their employees and their families

If the spouse of the Govt. Employee is employed in Railways, Pallavan Transport or similar organisations and if he/she is allowed and availed leave Travel Concession for his/her family including the employee in State Govt. Service, the

to travel all over India and within Tamil Nadu. spouse in State Govt. Service is not eligible for leave travel concession. Also before granting Leave Travel Concession, to a Govt. servant a certificate may be obtained from him/her to the effect the spouse of the Govt. servant concerned is not eligible for Leave Travel Concession in the organisation where he/she is working.

6. Whether the unspent portion of the L.availed under Leave Travel Concession due to death during the period can be recredited to his leave account and the claim for the onward journey that will be preferred by the legal heir of the deceased Govt. Servant admitted.

The unspente portion of the E.L.granted under the leave travel concession need not be recredited to the account of the deceased Govt. Servant But the claim for the onward journey preferred by the legal heir of the deceased Government servant may be admitted.

- 7. whether the Govt.servants who have engaged borrowed conveyances in connection with leave Travel concession are entitled for the reservation charges, also along with the eligible class of train fare.
- The Govt. Servants who have engaged borrowed conveyances in connection with Leave Travel Concession are not entitled for the reservation charges along with the eligible class of train fare.
- 8. Whether a Govt. Employee put in one or two years of service not eligible for leave travel concession as per the rule, can be included as one of the family members of his/her father or mother who is a Govt. Servant for this purpose alone and avail the concession.

A Govt. employee put in one or two years of service not eligible for leave travel concession as per rule, cannot be included as one of the family members of his/her father or mother who is a Govt.servant for the purpose of leave Travel concession.

9. Whether a Govt. servant who applies for leave travel concession to a particular destination gets it sanctioned and later changes the destination according to his own convenience can claim leave travel concession for such journey performed by him.

The Govt. Servant who claims travelling allowance for a place chosen by him other than the place to which he was permitted and which costs more than the orginal trip is not eligible for payment.

10) Whether a Govt.servant whose appointment is irregular though put in a long service and whose services are not regularised which is not due to his fault is eligible for Leave Travel Concession.

A Govt.servant whose appointment is irregular though put in a long service and whose services are not regularised which is not due to his fault is not eligible for Leave Travel Concession.
